\_\_\_\_\_ (Vendor) is contracting to rent a Flea Market/Commercial space at the 2018 Steam-O-Rama, October 4-7, 2018. Single space size is 30' frontage and 20' deep. **Cost of a single space is \$65.00 for the four days or any part thereof.** Multiple spaces and a few odd sized spaces are available on a first come-first served basis. Every effort will be made to accommodate your needs. Please list any special considerations below.

\*Spaces are 100% payable in advance, **NO REFUNDS.** All spaces must be reserved by September 1, 2018 by the returning vendor, to insure placement on the same lot as the previous year. Reservations received after that time will be handled on a space available basis. Check in at the Flea Market Office Camper on arrival for placement.

\*Spaces reserved by a vendor must be used by the purchasing vendor. There will be no trading or holding over of spaces without the written request from the vendor and return written consent of the Flea Market Managers.

\*Primitive camping is available on your space, or elsewhere on the show grounds. **No hookups** are available.

\*Pets are allowed, but must be in your presence and under control at all times.

\*Please give a brief description of the merchandise to be sold. Some restrictions are listed below.

\*Vendors may move in any time after Monday 5:00 P.M. of show week. Your display should be set up by 11:00 A.M.

Thursday and Friday, and 8:00 A.M. Saturday and Sunday, closing at dark daily except Sunday.

\*PA State Tax Certificates must be on file in the office. Please return a copy with your application if we do not have one on file. If you are unsure, just send one! No one will be allowed to set up without a certificate. Out of state tax certificates are not valid in PA.

I, the undersigned, agree to take full responsibility for my person, property and merchandise. I will not hold the E.A.S.E. & O. E. S. responsible for any loss, damage or injury to my person, property or merchandise.

**NO SALES OF ANY TYPE OF FIREARMS, AMMUNITION, MARTIAL ARTS WEAPONS, DRUGS OR RELATED ITEMS, SEX RELATED TOYS AND MATERIALS OR SALE OF PETS ARE ALLOWED. NO PROJECTAL TOYS THAT CAN CAUSE HARM WILL BE ALLOWED. NO ALCOHOLIC BEVERAGES ARE ALLOWED ON THE SHOWGROUNDS FOR CONSUMPTION OR SALE. All items not sold or debris remaining from the vendor stands must be removed by the vendor before they leave.

Vendors will not be allowed to sell any food for consumption on the grounds.

Flea Market, Craft and Antique vendors must have a valid PA State Sales Tax Certificate on file. Please return a copy with your payment. The Society reserves the right to demand sales tax proof.
